Dear Committee Members:

A special Financial Management Committee meeting has been requested to amend Resolution Number 432-2016 so that it authorizes the sale of 2016 Real Property Tax Auction Lot Number 7 (the "Property") to Ms. Amy Conley instead of, the original high bidder, 29 LD LLC.

Resolution Number 432-2016 approved the sale of delinquent tax properties held out for public auction on May 25, 2016. Pursuant to that resolution, the Board approved the sale of the Property located at 55 Main Street in the Village of Phelps, to 29 LD LLC (the "Buyer") in an amount of \$20,000.

Following the auction, the Buyer walked away from the Property forfeiting its deposit and any rights or claims to the Property. The Property was subsequently put up for public auction in a standalone online-auction. The online-auction began September 2, 2016, and expired September 29, 2016. The high bidder was Ms. Amy Conley in the amount of \$10,200.

Therefore, we kindly request that the Financial Management Committee recommend to the Board approval of an amendment to Resolution Number 432-2016 reflecting the new buyer and bid amount for the Property.
