Resolution: Authorization to Contract with GoGo Grandparent Transportation Services – 2021-2022

AUTHORIZATION TO CONTRACT WITH GOGO GRANDPARENT TRANSPORTATION SERVICES - OFA 2021-2022

WHEREAS, The Ontario County Office for the Aging has funding from the New York State Office for the Aging to provide transportation to medical and other essential appointments for Ontario County residents age 60 or over who have no other means of transportation; and

WHEREAS, The Office for the Aging has determined that the most efficient and convenient way to support the mobility of older adults is through a contract with GoGo Technologies, aka GoGo Grandparent, 875 Vermont St. Unit 203 San Francisco, CA 94107; and

WHEREAS, GoGo Grandparent will operate an automated senior rides hotline that allows the County's older residents to access and use Lyft or Uber with a phone call; and

WHEREAS, GoGo Technologies will be paid \$10 per member per month fee for each client in addition to being paid for trips authorized by the Office for the Aging; and

WHEREAS, Funds have been allocated for this purpose in the Office for the Aging budget; and

WHEREAS, The Health and Human Services Committee has reviewed this request and has approved this resolution; now, therefore, be it

RESOLVED, That upon review and approval of the County Attorney as to form, this Board of Supervisors does hereby authorize a contract between the Office for the Aging and GoGo Technologies for the period of April 1, 2021 – March 31, 2022 at a total cost not to exceed \$25,000; and further

RESOLVED, That the County Administrator is hereby authorized and directed to sign said agreement.
