**MINUTES**

**PUBLIC HEALTH**

*a. Resolution: Authorization to Contract with S2AY Rural Health Network, Inc. - 2021*

Mary Beer presented a resolution to contract with S2AY Rural Health Network.

Supervisor Rich Russell motioned to approve the resolution, seconded by Supervisor Fred Wille. The motion carried.

*b. Performance Management*

Mary Beer reported the Early Intervention Department went through a mock Medicaid review with the state and passed with flying colors. There were no issues identified.

*c. Updates*

Public Health Director Mary Beer gave an update of the COVID-19 Pandemic, noting the following:

- They continue to lead the region in vaccinations
- Pop up clinics are being done at larger businesses and schools.
- Ten cases currently in the hospital with no new deaths.

a. <b>Resolution:</b> <i>Authorization to Contract with Self Direct, Inc. for Personal Emergency Response Systems – OFA – 2021-2022</i>	<p>Irene Coveny presented a resolution to contract with Self Direct for personal response systems. They did increase the amount in the budget at \$54,500.</p> <p>Supervisor Norm Teed motioned to approve the resolution, seconded by Supervisor Tammie Hicks. The motion carried</p>
b. <b>Resolution:</b> <i>Authorization to Contract with Genesee Region Home Care of Ontario County, Inc. d/b/a Home Care Plus for Personal Care Services – OFA – 2021-2022</i>	<p>Ms. Coveny presented a resolution to contract with Home Care Plus for personal care services for 2021-2022. The rates for personal cares services have gone up per hour from \$27 to \$30.80 and \$135 per visit for nursing supervision.</p> <p>Supervisor Norm Teed motioned to approve the resolution, seconded by Supervisor Fred Wille. The motion carried.</p>
c. <i>Updates</i>	<p>Ms. Coveny gave the following updates:</p> <ul style="list-style-type: none"> <li>• They opened two of their congregate sites today, Shortsville and Geneva.</li> <li>• They will open Honeoye next week.</li> <li>• They hope to open the Salvation Army site in June as soon as their headquarters gives them the ok.</li> <li>• They are talking to the church in Gorham when to reopen.</li> <li>• The whole staff is back in the office from remote work.</li> <li>• They are starting office visits by appointment and plan to start going out and seeing the clients this week.</li> </ul>
<b>DEPARTMENT OF SOCIAL SERVICES</b>	
a. <i>Updates</i>	<p>Eileen Tiberio gave the following updates</p> <ul style="list-style-type: none"> <li>• Still waiting for clarification from the state how the treasury money will roll out.</li> <li>• Her staff is back in the office at least two days a week.</li> </ul>
