Ms. Puma let the committee know that per our sewer rent Local Law, Section 4.0 states, "Sewer Rents shall be due and payable in equal quarterly installments on April 1, July 1, October 1, and January 1 in each year, with the first payment being due when connection to the District sewer line has been made. Sewer rents shall be due and payable for the full quarter in which connection is made. Charges will not be prorated for a portion of the quarter. Sewer rents shall continue to be payable whether or not the premises are occupied."

At this time, the department has deviated from this and has not started billing residents until they received a Certificate of Occupancy for their home. Since COVID, there has been a lag in issuing Certificates of Occupancy. This has allowed for people to already be occupying their homes and not paying sewer rent. Going forward the department will be following the Local Law and starting to bill customers at the time of connection.
