Towns of Bristol, Canandaigua, Canadice, East Bloomfield, Farmington, Geneva, Gorham, Hopewell, Manchester, Naples, Phelps, Richmond, Seneca, South Bristol, Victor and West Bloomfield, the Cities of Canandaigua and Geneva, and the Villages of Clifton Springs, Naples and Phelps

Background: County Agricultural Districts

In 1971, the state legislature enacted Article 25 AA creating the agricultural district program to "provide a locally-initiated mechanism for the protection and enhancement of New York state's agricultural land as a viable segment of the local and state economies and as an economic and environmental resource of major importance."

Ontario County Agricultural District 1 was created in 1972 and comprised 5,300 acres of farmland in the Towns of Bristol and Canandaigua. Ten agricultural districts were created – the last, Agricultural District 10 in 1982 was comprised of 7,533 acres of farmland in the Town and Village of Naples. Upon completion of this review, there will be 256,513 in Consolidated Agricultural District 1.

Note on Table 3 The amount of land in agricultural operations was determined by summing the acreage of parcels that received an agricultural exemption in 2020. A review of aerial photos indicated that there were a negligible number of parcels that were part of an agricultural operation that were not receiving an agricultural exemption making this a credible figure to use as number of acres in agricultural operations in the District.

Modifications to an Agricultural District

Once an agricultural district is established, the only time a landowner can request that their land be removed from the district or a municipality can request a change is during the eight-year review period. However, landowners can request that viable agricultural land be added every year during a thirty day period that was established under Sec. 303 b. of the law after following a procedure similar to the agricultural district review process. Ontario County established November 1-30 as its annual period.

Consolidated Agricultural District 1 will be next reviewed in 2028.
